## Medical and Health Humanities Working Group

In 2019, the Irish Humanities Alliance (IHA) established a working group on Medical and Health Humanities to represent the breadth and depth of medical and health humanities research across the island of Ireland. After a short hiatus, the working group was reformed in 2024, comprising representatives from Dublin City University (DCU); Maynooth University (MU); South East Technological University (SETU); Trinity College Dublin (TU); University College Cork (UCC); University College Dublin (UCD); University of Galway (UG); University of Limerick (UL) Queen's University Belfast (QUB); and Ulster University (UU). We have compiled this document as a follow up to the Medical Humanities Research document previously published in 2017. This research snapshot is intended provide an insight into the breadth and depth of Irish humanities research related to the areas of health and medicine. The document is based on responses to a call from members of the working group and the member's expertise and knowledge of this research area. We do not claim, therefore, this to be the definitive guide to current medical humanities research and see it, rather, as an indication of the work being done in these fields and the researchers who are involved.

## **About Medical and Health Humanities**

Medical humanities researchers and scholars draw on the strengths of a wide variety of disciplines including arts, humanities, social sciences and the health sciences to bring new perspectives to the areas of medicine and health. They explore the social, cultural, philosophical and historical dimensions of health and medicine, not least relating to how we can learn from pandemics, while offering a critique of traditional practices and current healthcare priorities.

Medical and health humanities research emphasises the ways humanities knowledge and practice can enhance health and wellbeing. Researchers in medical history and medical geography explore the social and cultural dimension of medicine; the history of disease and treatments; the effects of location & climate on health; contagion; spatial perspectives in public health; demographics and the stigmas associated with certain ailments. Medical philosophers and anthropologists explore such issues as the ethics of medicine and practice within the health sciences; memory and ageing; the experience of living with illness and the healing process. Others draw on the arts and humanities to develop alternative and complementary therapies based on art; dance; drama; literature; music and poetry.

As will be clear from this document, the medical and health humanities scholarship Is a vibrant and growing area of research across the island of Ireland. Our universities on the island have considerable research activity in this area while this is also a growing field in other institutions. We hope that this overview will be a catalyst for further development of joint working between academics in Ireland, provide an information resource for further development of networks and wider research opportunities, and provide insights into the potency of this approach to health and well-being to those leaders and bodies directing strategies for research and development in Ireland.

## An Grúpa Oibre um na Daonnachtaí Leighis agus Sláinte

In 2019, bhunaigh <u>Comhaontas Daonnachtaí na hÉireann (IHA)</u> grúpa oibre um na Daonnachtaí Leighis agus Sláinte d'fhonn léargas a fháil ar fhairsinge an taighde atá á dhéanamh ar oileán na hÉireann i réimse na ndaonnachtaí leighis agus sláinte. Tar éis bearna ghairid, athbhunaíodh an grúpa oibre in 2024 agus é comhdhéanta d'ionadaithe ó: an Coláiste Ollscoile, Baile Átha Cliath; Coláiste na hOllscoile, Corcaigh; Coláiste na Tríonóide, Baile Átha Cliath; Ollscoil Chathair Bhaile Átha Cliath; Ollscoil Luimnigh; Ollscoil Mhá Nuad; Ollscoil na Banríona, Béal Feirste; Ollscoil na Gaillimhe; Ollscoil Teicneolaíochta an Oirdheiscirt; agus Ollscoil Uladh. Tá an doiciméad seo curtha i dtoll a chéile againn le leanúint den doiciméad *Taighde ar na Daonnachtaí Leighis* a foilsíodh siar in 2017. Tá sé i gceist ag an taighde seo léargas a thabhairt ar fhairsinge an taighde atá á dhéanamh in Éirinn i réimse na ndaonnachtaí leighis agus sláinte. Tá an doiciméad bunaithe ar fhreagraí a fuarthas ó bhaill an ghrúpa oibre, chomh maith leis an saineolas agus an t-eolas atá ag na baill ar an réimse taighde seo. Níl muid ag maíomh, mar sin, gur treoir chríochnúil é seo faoin taighde ar fad atá á dhéanamh faoi láthair i réimse na ndaonnachtaí leighis. Ina ionad sin, tá muid ag breathnú air mar léiriú ar an obair atá ar siúl sa réimse seo agus ar na taighdeoirí atá i mbun na hoibre sin.

## Maidir leis na Daonnachtaí Leighis agus Sláinte

Téann taighdeoirí agus scoláirí i réimse na ndaonnachtaí leighis i dtuilleamaí láidreachtaí raon leathan disciplíní, lena n-áirítear na healaíona, na daonnachtaí, na heolaíochtaí sóisialta agus na heolaíochtaí, le dearcthaí nua a thabhairt chuig réimsí an leighis agus na sláinte. Scrúdaíonn siad gnéithe sóisialta, cultúrtha, fealsúnachta agus stairiúla na sláinte agus an leighis – an chaoi ar féidir linn foghlaim ó phaindéimí go háirithe – agus déanann critíc ag an am céanna ar chleachtais thraidisiúnta agus ar thosaíochtaí reatha cúraim sláinte.

Leagtar béim i dtaighde sa réimse seo ar na bealaí ar féidir le heolas agus cleachtadh sna daonnachtaí sláinte agus folláine a fheabhsú. Taighdeoirí a dhéanann plé leis an stair leighis agus an tíreolaíocht leighis, déanann siad iniúchadh ar ghné shóisialta agus chultúrtha an leighis; stair na ngalar agus na gcóireálacha; éifeachtaí suímh agus aeráide ar shláinte; tógáil galar; dearcthaí spásúla i sláinte an phobail; próifílí déimeagrafacha agus na stiogmaí a bhaineann le tinnis áirithe. Breathnaíonn fealsúna agus antraipeolaithe leighis ar shaincheisteanna amhail eitic an leighis agus an chleachtaidh laistigh de na heolaíochtaí sláinte; cuimhne agus dul in aois; maireachtáil le tinneas agus an próiseas leigheasta. Téann daoine eile i dtuilleamaí na n-ealaíon agus na ndaonnachtaí le teiripí malartacha agus comhlántacha a fhorbairt, iad bunaithe ar an ealaín; an damhsa; an drámaíocht; an litríocht; an ceol agus an fhilíocht.

Mar is léir ón doiciméad seo, is réimse taighde iad na daonnachtaí leighis agus sláinte atá beo beathach agus ag fás ó cheann ceann oileán na hÉireann. Tá méid nach beag taighde ar bun cheana féin sa réimse seo in ollscoileanna ar fud an oileáin agus is réimse é atá ag dul i méid in institiúidí eile freisin. Tá súil againn go spreagfaidh an forbhreathnú seo tuilleadh comhair idir acadóirí in Éirinn, go gcuirfidh sé bonn faisnéise faoi fhorbairt líonraí agus deiseanna taighde go ginearálta amach anseo, agus go dtabharfaidh sé léargas ar a chumhachtaí atá an cur chuige seo i leith na sláinte agus na folláine do na ceannairí agus na comhlachtaí siúd a cheapann straitéisí taighde agus forbartha in Éirinn.
